**RESOLUTION NO. 22-08**

**RESOLUTION FOR ADOPTING A FEE SCHEDULE FOR  
BUILDING CODES ORDINANCE**

**WHEREAS**, the Kettle Falls Building Codes Ordinance requires that the City Council establish a schedule of fees, charges, and expenses for matters pertaining to the Building Codes Ordinance; and

**WHEREAS**, it is recognized that the public in general benefits from plan review and inspection, and, at the same time, it is fair that the applicants and developers share a larger portion of the costs generated by staff review and inspection;

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Kettle Falls, Washington, that the following is the fee schedule for the Kettle Falls Building Codes Ordinance.

**SECTION 1**

8. **CERTIFICATION OF OCCUPANCY.** For a Certificate of Occupancy to be issued, there shall be a charge of Twenty-Five Dollars (\$25.00) when the Certificate of Occupancy is not involving any construction work. Inspections made prior to and for the express purpose of granting a Certificate will be made as Safety Inspections and the fee will be charged accordingly. No charge will be made for a Certificate directly resulting from a Safety Inspection or directly resulting from change in occupancy for which a building permit was obtained.

**SECTION 7**

**INVESTIGATION FEES: WORK WITHOUT A PERMIT**

1. Investigation. Whenever any work for which a permit is required by the City of Kettle Falls Building Code has been commenced without first obtaining said permit, a special investigation shall be made before a permit may be issued for such work.
2. Fee. An investigation fee, in addition to the permit fee, shall be collected whether or not a permit is then substantially issued. The investigation fee shall be equal to the amount of the permit fee required by this code. The minimum investigation fee shall be the same as the minimum fee set forth in this resolution. The payment of such investigation fee shall not exempt any person from compliance with all other provisions of this code nor from any penalty prescribed by law.

**SECTION 8**

**FEE REFUNDS**

1. The Building Official may authorize the refunding of any fee paid hereunder, which was erroneously paid or collected.
2. The Building Official may authorize the refunding of not more than 80% of the plan review fee paid when an application for a permit for which a plan review fee has been paid is withdrawn or cancelled before any plan review effort has been expended.

The Building Official shall not authorize the refunding of any fee paid except upon written application filed by the original permittee not later than 180 days after the date of fee payment.

This Resolution shall take effect and be in full force from the date of passage.
